In consideration of my participation in Bend Lacrosse Booster Club [hereinafter "the Club"] sponsored events and activities, I agree to the following:

1) **Waiver and Release:** I am fully aware of and appreciate the risks, including the risk of catastrophic injury, paralysis and even death, as well as other damages and losses, associated with participation in a lacrosse event and related sports conditioning activities, including the risk of contracting the novel coronavirus and experiencing symptoms and complications from COVID-19. I further agree on behalf of myself, my heirs and personal representatives, that the Club, along with coaches, officials, referees, volunteers, employees, agents, sponsors, officers and directors of these organizations, shall not be liable for any injury, loss of life or other loss or damage occurring as a result of my participation in an the Club sponsored event or activity.

2) **Medical Attention:** I hereby give my consent to the Club to provide, through a medical staff of its choice, customary medical/athletic training attention, transportation and emergency medical services as warranted in the course of my participation in the Club sponsored or sanctioned events.

3) **Readiness to Compete:** I will only participate in those competitions or activities in which I believe I am physically and psychologically prepared to participate. I will ensure that I will familiarize myself with the rules of the game and of the field and will to the best of my ability play under control and avoid injury to myself and other persons playing the game. Indoor lacrosse leagues will play by field lacrosse rules. Boarding and cross-checking are specifically excluded in these rules.

4) **Photographs:** I understand that the Club will take photographs of its events and participants and that the Club may post these pictures on its Website and/or Social Media that are viewable by the general public.

5) **US Lacrosse Membership:** I will maintain an active US Lacrosse membership while participating on any team or league sponsored by the Club.

6) **Refund Policy:** I understand that the Club will not refund any part of the registration fee after the first official practice of the season. RegSaver insurance is available for purchase during the registration process.
